## SADDLE & SIRLOIN LEGACY MEMBERSHIP

**Purpose:** To allow children of current members who no longer qualify to use the parent's membership, to apply for a special membership with no initiation fee, no debt assessment or voting rights, having dues of \$75 per month and a food minimum of \$25 per month.

This special membership would be available as long as the parents remain members and/or until the age of 30, at which time these members would have the option of purchasing an intermediate membership with \$500 initiation fee and increased dues plus debt assessment.
